

Terms and Conditions of the “Travel with IberiaPluStore” competition

1. Purpose

AVIOS GROUP (AGL) LIMITED, branch in Spain, with registered office at Martínez Villergas 49, 28027, Madrid, tax number NIF W-8262063-D. AGL is holding a campaign to promote Avios collection and client activation.

2. - Scope and Participants

The competition is open to Spanish residents over the age of 18.

Participants should be Iberia Plus card holders to be eligible. To receive the prizes, participants should be previously registered at www.iberia.com/iberiaplus.

Participation is free, and it is open to all Iberia Plus card holders purchasing a minimum of 1 Euro in any of the ecommerce stores that the IberiaPluStore links you to from Iberia.com.

3. - Period

This campaign starts on November 23, 2015 at 00:00 (CET) (“**Commencement Date**”) and ends on December 31, 2015 at 23:59 (CET) (“**End Date**”). The period comprised between Commencement Date and End Date shall be called “**Campaign Period**”.

4.-Prizes

The prizes correspond to Aviosⁱ awards consisting on:

4.1 One prize by draw:

The following prize will be drawn among all the Iberia Plus eligible participants who, re-directed from the IberiaPluStore link, “purchase” a minimum of **1 EURO** on any of the online retailers of the eStore during the Campaign Period. Prize being:

- One prize of a total of 165,000 Avios for a single winner. The Avios could be redeemed on any of the Iberia Plus programme redemption options available on the tables of Iberia.com.
